Getting Here

Airport Pick Up

We can provide a comfortable private van to pick you up from the airport or your hotel and bring you directly to your villa. The rides are affordable and the scenery is very pleasant. Driving time is about 2 ½ hours. Along the way stop at the Tarcoles Bridge to stretch your legs and see large Costa Rican Crocodiles!

Regional Flights

Speak to your Concierge to see if your international flight arrival time is compatible with a regional flight to Quepos. Flight time is approximately 25 minutes.

Private Charter Flights

Minimize your travel and waiting time by allowing us to charter you a private flight from San Jose to Quepos, specifically according to your personal schedule.

Car Rentals

As a registered car rental agent, we can coordinate vehicles of all types and sizes and have them dropped off directly to you at the villa after you have arrived. Reserve in advance!

Driving

Your Concierge can provide maps, tips and directions for your travel destinations. If you are driving yourself we highly recommend you have GPS and a cellphone.



General Information

Traveler's Insurance: We recommend that all of our guests have Traveler's Insurance prior to departing for their vacation.

No Smoking Policy: We do not permit smoking inside any of the homes. Guests may smoke only in outdoor areas.

Housekeeping Service: Housekeeping service is provided daily with the exception of Sundays. When the housekeeper leaves at the end of the day she will lock up if no one is home - so please make sure you carry a key with you.

Villa Security: Petty theft can be common in Costa Rica. We recommend that you always lock up all doors and windows when you leave or when you go to sleep at night. Most of our villas have an alarm system that we provide use to guests for additional security. We do not have security problems and we don't want them, so please lock up tight and use the alarm. This will be explained to you at check-in by your Concierge.

Laundry Service: For your convenience the villa is equipped with laundry hampers, where you can leave items to be cleaned. Clothing will be laundered every other day during your stay and returned to you the same day, or the next day at the latest. Your sheets and bedding will be washed mid-week. Please re-use towels when possible to conserve resources and energy.

Maintenance: We do our best to keep our villas in tip-top condition for you. However we greatly appreciate any observations you may have during your stay. Please report to your concierge any details that may require attention.

Gardening/Pool: Pools will be attended to daily and maintained. Ask your concierge if you have questions about the pool cleaning schedule for your villa.

Wireless Internet: Your WiFi password will be provided in your Guest Services Directory at the villa. Sometimes the network might go down which can usually be amended by simply unplugging and re-plugging the router. If not, please report to your concierge.

Lighting: Your housekeeper will turn on your exterior lights upon departure and turn them off upon arrival the next day - with the exception of Sunday. Some villas may have exterior lights, which are on automatic timers.

Long Distance Calls: The phone in the villa is unavailable for international calls.

Check-out Procedure: Your concierge manager will take care of all check-out procedures with you prior to your departure. Check out time is no later than 10:00 a.m. unless permission for a late departure has been specified.



Getting Around Locally

Using Taxis

We suggest that you use the official government taxis and we suggest that you allow for your Villa Concierge to organize this service for you, so that we can ensure the best and safest drivers. Official government taxis are red taxis with yellow triangles showing their taxi number on each side of the vehicle. The taxi driver should have a meter that is used to stipulate the price from one location to another, or the price should be confirmed in advance. You can always ask for the cost before you get in to ensure a fair price. "Pirate" taxis are not permitted to enter the gated community grounds where Villa Feliz, Villa Paraiso and Villa Reserva are located. In Quepos, taxis line up along the main one-way street, opposite the bus station. There are usually a few taxis at the beach as well, ready to bring beach-goers home. Taxis are readily-available and can be coordinated with just 5 minutes notice by your Villa Concierge.

Using the Local Bus System

You will probably notice the public bus during your stay in Manuel Antonio, as it transports many beach-goers, travelers and locals, back and forth throughout the day. For guests staying at Villa Amarilla, Villa Feliz, Villa Paraiso or Villa Reserva, there is a public bus stop located about 50 meters away at the main road intersection. For Guests staying at other villas, inquire with your Concierge if you wish to use the local bus system. Buses run approximately every 30 minutes in both directions, either heading to the Manuel Antonio National Park and beaches or to downtown Quepos. Once the bus gets to where the National Park and beaches are, it drives around a round-about and goes back towards Quepos, because the road dead-ends at that point. The fare per person is less than U.S. \$1 per ride. (usually 250 colones - about 50 cents.)

Walking

When walking around in Manuel Antonio or Quepos, it is a good idea not to carry your original passport, rather a copy of it along with a copy of the stamp of entry. You can simply take a picture of your passport page with your photo and the page with stamp of entry and carry this with you. We suggest that you leave your passports in a security safe at your Villa. It is advisable to carry only the cash/credit cards and ID that you will need. Do not carry excessive belongings or wear a lot of jewelry.



Exercise

If you are looking to get your feet wet, the public beach in Manuel Antonio is another excellent place to exercise, especially at low tide when there is more space to run the length of the beach. We can schedule Personal Trainers for our guests or ask your concierge for directions to one of the gyms that are open to the public in town. Please also ask your Villa Concierge for hiking trail suggestions.

Money & Tipping in Costa Rica

Remember: Call your bank before you leave your country to inform them that you are going to be using your Credit Card in Costa Rica. Otherwise they will block your card as an anti-fraud precaution.

Money

Prices in Costa Rica are frequently listed in U.S. dollars, especially by tour operators, spas, restaurants and other tourism or hospitality providers. U.S. dollars are widely accepted, but the standard unit of currency is the colón (plural: colones). Colones are handy to have for things like paying taxis, going to the supermarket, buying souvenirs, and eating out. Most places accept credit cards.

ATM's

There are various banks around, but the ATM's offer both Colones and U.S. dollars. There are several in Manuel Antonio and others in Quepos.

Quepos: Banco San Jose, Banco Costa Rica and the Marina Pez Vela.

Manuel Antonio: Banco Promerica and Banco Costa Rica.

If you go to the bank to exchange currency, you will need to show your original Passport.

Tipping

Questions in regard to tipping are commonly asked by travelers. In Costa Rica, tipping is a regular and appreciated practice within the tourism and hospitality industry. We do not embed in our invoices an additional service charge to distribute among our employees. In recognition of work well done by your housekeeper or Concierge, tips are graciously accepted as a big "thank you".



These are suggested gratuity amounts based on the normal rates established in the area but may vary depending on the level of service you receive and your level of satisfaction.

Restaurants: 10% on top of the already included service charge. (The 10% that is included does not go directly to your wait staff, rather is distributed among kitchen and restaurant staff.)

Private Transfers/Chauffeurs: 15-20% of total trip price

Sport fishing Crew: 15-20% of total cost for the day. (You can give this to the boat captain to share and distribute.)

Housekeepers: \$50-\$200 per week / per home

Maintenance/Bellboy: \$25-\$100/per week / per home

Concierge: \$200-\$400 per week / per home

Tour Operators: 15-20% of tour price

Chef: 20% of your culinary services

Please note that there will be a 4% surcharge applied your check-out invoice when paying by credit card.

Health & Safety

Do I need to take malaria pills or get certain vaccinations?

At the time of this writing, no immunizations, shots or vaccinations are compulsory to enter Costa Rica from North America or Europe. Check with your own doctor for recommendations.

If I need medicine, can I easily get it?

Pharmacies are usually open from 8am to 8pm but might open later on Sundays. Many Pharmacies have doctors on site at some point during the day. Your concierge can call a doctor to make a house visit to you if you fall ill and request a doctor.

Is it safe to eat the local fruits and vegetables?

Yes – in Costa Rica there are many small farms that grow produce to sell at farmers markets, along the side of the road, or to local supermarkets. Our local farmers market is held in Quepos, close to the waterfront, Friday evenings and Saturday mornings. As always, you should properly wash and clean fruit and vegetables before you eat them.



Is it safe to swim in the ocean?

At Manuel Antonio public beach, many enjoy swimming and surfing. There are lifeguards, but they are not always on duty and don't cover the whole beach, so check for where the lifeguards are on patrol and swim or surf at your own risk. Be conscious of riptides. If you get stuck in one, don't swim against the current; rather, swim parallel to the shore. Never panic - usually strong currents will bring you to calmer water. Based on the fact that there are strong rip tides in some areas, we recommend using extreme caution when swimming!

Is the tap water safe to drink?

Yes, tap water is safe to drink. Nonetheless, bottled water is also provided at your villa.

What Should I do in Case of an Emergency?

Contact your Concierge at ANY time for any emergency assistance. More detailed information is provided in the in-home Guest Services Directory which your concierge will show you when you check in. Furthermore, you can dial 911 and request an English speaking dispatcher. Note the Ambulance dispatched will take the patient to the nearest medical facility, not necessarily a private facility. On vacation, if you call any emergency lines on your own, make sure you know your current location and address.
