The Florida Board of Bar Examiners, through its Chair, the Honorable Scott N. Richardson of West Palm Beach, Florida, has announced that the grades from the July 2017 General Bar Examination have been approved for release by the Supreme Court of Florida.

On July 25-26, 2017, 3,247 applicants took the Bar Examination in Tampa, Florida. The Supreme Court posted the pass/fail results for each applicant on its website and score reports were mailed to each applicant today.

The Court approved 1,553 candidates for admission to The Florida Bar on September 18, 2017, and Chief Justice Jorge Labarga has announced that they may be sworn in as members of The Florida Bar. Formal induction ceremonies to swear in the new attorneys will be held at the Supreme Court, Second, Third, Fourth, and Fifth District Courts of Appeal on Wednesday, October 4, 2017.
