### **COMPLAINT**

Pursuant to Florida Statutes §106.25, the undersigned ("Complainant") files this complaint against Frank Henry White ("White") for violations of Florida Statutes §§106.07, 106.08. In support thereof, Complainant alleges the following non-hearsay facts in support of its complaint (the "Complaint"):

### A. FACTUAL BACKGROUND

- 1. On or about October 12, 2017, White filed to run as a candidate for Attorney General. White remains a candidate for Attorney General. Attached as Exhibit "A" to this Complaint is a true and correct copy of the Statement of Candidate filed by White.
- 2. In his Statement of Candidate, White declared that he had read and was familiar with Chapter 106, Florida Statutes.
- 3. White currently serves as a representative in Florida's House of Representatives. Prior to filing the Statement of Candidate referred to above, White has filled out and declared on at least one other occasion familiarity with Chapter 106, Florida Statutes. Attached as Exhibit "B" to this Complaint are true and correct copy of the prior Statement of Candidate forms filed by White.
- 4. Prior to declaring as a candidate for Attorney General, White filed a Form 6 annually for the previous three years with the State of Florida, Commission on Ethics (the

"Ethics Commission"). Form 6 is a Full and Public Disclosure of Financial Interests that is required to be annually filed by various governmental officials, including representatives of Florida's House of Representatives and candidates for state wide office, including Attorney General. Officials, like White, swear under oath that the information that they provide the Ethics Commission is true, accurate, and complete. Attached as Exhibit "C" to this Complaint are the Form 6 forms filed by White for 2015, 2016, and May 31, 2018.

- 5. White's 2015 Form 6 discloses a net worth of \$2,014,075. \$417,743.00 of his net worth came from his primary residence. In three bank accounts, White disclosed that he had \$54,449.14 on hand. White disclosed a salary from Sandy Sansing Imports, Inc. of \$120,750. In addition, White disclosed approximately \$30,000 of income from securities.
- 6. White's 2016 Form 6 disclosed a net worth of \$2,465,260. \$622,000 of his net worth came from his primary residence. In the same three bank accounts, White disclosed that he had \$57,040.68 on hand. White disclosed the same salary from Sandy Sansing Imports, Inc. of \$120,750. White also disclosed an additional \$3,929 of salary from the State of Florida, which presumably resulted from his election as a representative to the Florida House of Representatives. Finally, White disclosed approximately \$81,431 of income from securities.
- 7. In his 2017 M10 Campaign Contribution form, White disclosed making a contribution of \$1,500,000, to his campaign. If the funds had come from him, he would have had to liquidate more than 50% of his personal assets. \$1,500,000 is an over 26 times increase in cash on hand by White than White had less than ten months earlier. A true and correct copy of White's 2017 M10 Contribution report is attached as Exhibit "D" to this Complaint.
- 8. White's campaign spokeswoman, Erin Isaac, told reporter William March in February 2018, that White's wife, not him, received a stock dividend in September 2017 (one

month or less prior to White declaring his run for Attorney General). And, the \$1,500,000 contribution was from that stock dividend payment.<sup>1</sup>

- 9. In other words, White's spokesman disclosed that White's wife made a campaign contribution in the amount of \$1,500,000 or 50 times more than the legal limit. To presumably conceal the source of the contribution, White represented in his disclosure form that the contribution came from him.
- 10. In his 2018 M5 Campaign Contribution form, White disclosed making a second contribution of \$1,250,000, to his campaign. If the funds from both contributions had come from him, he would have had to liquidate all of his personal assets, plus had his assets appreciate or otherwise increase \$285,000 approximately in less than eighteen months from his 2016 disclosure. \$2,750,000 is over 48 times the cash on hand that White has had at any time in the previous two years before he declared as a candidate. A copy of White's 2018 M5 Campaign Contribution form is attached as Exhibit "E" to this Complaint.
- General, White filed a Form 6 that provided his net worth and other financial information as of May 31, 2018. The Form 6 discloses that White's net worth as of that date is \$4,327,305 (less a \$1,250,000 check to his campaign that had not cleared). White disclosed the same salary from Sandy Sansing Imports, Inc. of \$120,750. An additional \$27,537 of salary from the State of Florida, which presumably resulted from his service as a representative to the Florida House of Representatives. In addition, White disclosed approximately \$138,939 of income from securities. Nothing in his income sworn to in his Form 6 explains how White was able to contribute more than his net worth to his campaign without reducing his assets in the last

seventeen months. Likewise, nothing in the Form 6 explains how White was able to contribute more than his net worth to his campaign.

12. Instead, the Form 6 shows an infusion of cash into Frank White's personal accounts from a source other than from Frank White's income or investments.

#### B. RELEVANT CAMPAIGN FINANCE LAW

- 13. Florida law defines a "contribution" as "[a] gift, subscription, conveyance, deposit, loan, payment, or distribution of money or anything of value, including contributions in kind having an attributable monetary value in any form, made for the purpose of influencing the results of an election or making an electioneering communication." See Fla. Stat. §106.011(5)(a).
- 14. Section 106.07 requires all candidates, including Respondent to file reports of, among other things, contributions received by the campaign.
- 15. As to contributions by persons, Section 106.07 requires "[t]he full name, address, and occupation, if any, of each person who has made one or more contributions to or for such committee or candidate within the reporting period, together with the amount and date of such contributions."
  - 16. Section 106.07 requires that:

[t]he candidate[, Respondent in this case,] and his [] campaign treasurer, in the case of a candidate, ... certify as to the correctness of each report; and each person so certifying shall bear the responsibility for the accuracy and veracity of each report. Any campaign treasurer, candidate, or political committee chair who willfully certifies the correctness of ary report while knowing that such report is incorrect, false, or incomplete commits a misdemeanor of the first degree, punishable as provided in s. 775.082 or s. 775.083.

17. Section 106.08(1) provides a limitation on contributions. As is relevant to Respondent, Florida law provides that "Except for political parties or affiliated party committees,

no person or political committee may, in any election, make contributions in excess of the following amounts: (1) To a candidate for statewide office or for retention as a justice of the Supreme Court, \$3,000."

- 18. Attorney General is a candidate for statewide office and contributions are limited to \$3,000 per person or entity.
- 19. Section 106.08(5)(a) states that "A person may not make any contribution through or in the name of another, directly or indirectly, in any election."
- 20. Florida law makes it unlawful and a felony for "Any person who knowingly and willfully makes or accepts two or more contributions in violation of subsection (1) or subsection (5) [of Section 106.08] commits a felony of the third degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084. If any corporation, partnership, or other business entity or any political party, affiliated party committee, political committee, or electioneering communications organization is convicted of knowingly and willfully violating any provision punishable under this paragraph, it shall be fined not less than \$10,000 and not more than \$50,000."
- 21. Florida courts have repeatedly found that monies from family members including spouses made with the purpose of influencing the results of an election are contributions subject to the limitations of Florida law. See In re Krause, 141 So.3d 1197, 1200 (Fla. 2014) (monies belonging to husband from his employment contributed to wife's campaign in excess of limitations violated campaign finance laws); In re Co. odny, 51 So. 3d 430, 431-32 (Fla. 2010) (finding that loan from father that was contributed by candidate to campaign in excess of limitation violated Florida campaign laws); In re Reeke, 933 So.2d 482, 489-92 (Fla. 2006) (concluding that dramatically increased salary payments by father given in advance of election were illegal contribution); In re Pando, 903 So.2d 902, 903-04 (Fla. 2005) (concluding that loans

from mother and step-father that were contributed by candidate to campaign constituted contributions in violation of limits and violated campaign finance laws); Beardslee v. Florida Elections Com'n, 962 So. 2d 390, 392-93 (Fla. 5th DCA 2007) (concluding that purchase of elections signs from money in joint account by husband constituted an illegal contribution).

22. The Florida Supreme Court defines "Probable cause" as "a reasonable ground of suspicion supported by circumstances strong enough in themselves to warrant a cautious person in belief that the named suspect is guilty of the offense charged." Johnson v. State, 660 So. 2d 648, 654 (Fla. 1995).

### C. CAMPAIGN VIOLATIONS

- 23. Based upon the above non-hearsay facts, probable cause exists to believe that Respondent, Frank White, violated Florida Statutes § 106.07 in certifying the source of funds in his 2017 M10 Campaign Finance Report and his 2019 M5 Campaign Finance Report.
- 24. Respondent, Frank White, certified that he was the contributor of the \$2,750,000. Instead, given his financial disclosures, it appears that his wife or others indirectly contributed amounts 90 times greater than the contribution limitation allowed by Florida law. In the two years prior to his decision to be a candidate for Attorney General, Respondent did not have the net worth nor the liquid assets to contribute \$2,750,000 to his campaign. His most recent disclosure fails to disclose any additional source of income sufficient from which these contributions could be made.
- 25. The fact that he obtained \$2,750,000, an amount in excess of his net worth, near in time to his decision to run or during his campaign is sufficient evidence to support a reasonable ground of suspicion that he obtained the money for purposes of influencing the results of an election.

- 26. Probable cause also exists to believe that on two occasions Respondent, Frank White, violated Florida Statutes § 106.08 by accepting contributions from indirect sources and made those contributions as his own to his campaign with the direct purpose and effect of evading the contribution limitations in violation of both Sections 106.08(1) and 106.08(5), Florida Statutes.
- 27. On two dates, Respondent accepted contributions totaling \$2,750,000, which exceeded his net worth and his liquid assets and wrote or instructed his treasurer to write that the contributions were from him and not their true source. The fact that he obtained \$2,750,000, an amount in excess of his net worth, near in time to his decision to run or during his campaign is sufficient evidence to support a reasonable ground of suspicion that he obtained the money for purposes of influencing the results of an election.
- 28. The sheer size of the contribution and his execution of his Statement of Candidate and his certification of understanding demonstrates that his violation is knowingly and willfully made, and not the product of some mistake or inadvertence.


